## ACC / Insurance Policies

It has come to our attention that a number of people may not have the protection they need from ACC and other insurance policies such as life insurance, income protection etc. As a result should something happen these people may be left vulnerable financially. This is an extremely serious situation and could mean that people lose everything they have worked for.

Let's look at a real life situation – James is a builder who has moved to Christchurch to assist with the rebuild. Last year he made a profit of \$17,000 and expects to earn \$45,000 this year. He has life insurance of \$500,000 and ACC Cover Plus. James is suddenly diagnosed with a serious illness and is off work for 21 weeks. As it was not terminal nor an accident he receives no compensation whilst off work. If you were in this situation could you afford to live on no income?

There are a number of insurance options which provide cover for differing scenarios and the cost may be less than you think. With events happening throughout the world it is more important than ever to be thinking about your income and ACC protection. 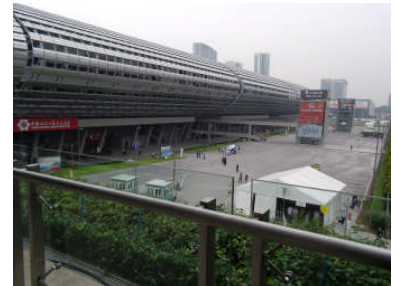
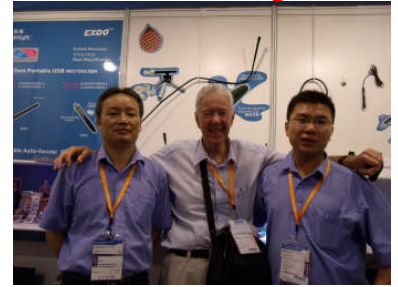
## New Earthquake Grant Available

Red Cross and Recover Canterbury have just received approval for a \$750 grant for financial advice to small businesses affected by the Canterbury earthquakes. This will be funded by an allocation from the \$70 million donations made to the Red Cross earthquake appeal.

It is available for any small business which has been negatively impacted by the earthquakes provided they have fewer than 10 employees. It can be used for professional legal and accounting advice relating to their business.
